- 8. New Business (information/action items)
  - a. Proposal for Foundation to assist with the costs of the LCC Meal Plan: The LCF Board approved the proposal to assist with the costs of the LCC Meal Plan with a contribution of up to \$20,000. Nancy Cardenas moved, Gary Felt seconded, motion passed unanimously
  - b. California Promise Program: LCC Interim Director of Enrollment

Services presented to the LCF Board about the California Promise Program, the status of LCF Scholarship recipients and other important issues concerning financial aid at LCC. Out of the 2017 high school graduates that received foundation scholarships, they 26 eligible to receive funding for the 2018-19 year. Thirteen of those students are currently enrolled in the Summer of 2018, 15 enrolled in 15 or more units for the Fall of 2018. Eight students need to enroll in courses to reach the 15 unit requirement. Of the new students awarded for the 2018-19 year, 44 of the 46 are currently enrolled, five need to enroll in more courses to reach the 15 unit requirement. Also, LCC was awarded \$115,000 for financial aid technology upgrades.
