- 7. <u>Lassen Cougar Enterprises Report</u> (information/action item)
 - a. People are in the campgrounds, Christy is not open, Merle has 20-30 campers, first day of reservations after the fire, no insurance coverage for lost business, the fire was two weeks ago, next week will be a slowdown, pickup on Labor Day, \$70,000-\$80,000 loss in revenue because of the fire. Scott McCullough arrived late and passed out a handout on the current Whaleback Fire Direct Losses, current loss is \$53,665. Two pontoon boats rented today at \$800. The reduction started at the site of smoke around the lake and the

campground. The refunds will pay off at the end, because we did the right thing. People will return to the campground next year because of our due diligence. We have returned to power two weeks ago, power went out on Friday and returned on Saturday. Sophia Wages expressed that the Foundation should send a letter to Officer Hill and others in appreciation of his efforts to keep the Marina open after the fires stopped.
