# A. WE 1A – Workplace Success

Proposal to add a new course for Work Experience.

Effective: Fall 2012

Ms. Gardiner indicated that work experience students need additional support dealing with basic work skill issues such as time management, reliability and meeting employer expectations. The proposed course will provide lecture on these and other topics relevant to all general work experience students. She is considering making the course a corequisite for students taking work experience especially general work experience for the first time. Ms. Mesloh will research the use of the Course Number. Will move to Action for the next meeting with any appropriate modifications.

# B. ART 23 – Beginning Printing

Update course outline to meet current standards. Make course outline meet current standards. This course will become part of the required courses for the AS in Digital Graphic Design and will be an elective in the AA-T Art History and AA-T Studio Arts. Effective: Fall 2012

Will move to Action for the next meeting with any appropriate modifications.

# C. <u>FS 23 – Ignitions Operations</u>

Update from inactive to active, change title form Firing boss to Ignitions Operations and add the following: **Student Learning Outcomes**Upon successful completion of this course, the student will:

- 1. Describe the role and responsibility of the firing boss for planning, execution, safety, training and coordination of a burning operation on an incident.
- 2. Describe commonly used firing devices; their characteristics, applications, safety and transportation requirements, maintenance needs and availability.
- 3. Be able to develop a firing plan demonstrating the knowledge of fire spread, firing techniques, bazards and resource needs.
- 4. Describe the purpose and elements of an on-going or post-firing evolution .

Reason for Change: To meet federal recognition.

Ms. Mouck requested the Course Content Review forms for the prerequisite and recommended preparation as well as assignment to the discipline of Fire Technology be submitted for Action along with the course at the next meeting.

# D. FS 70B – Engine Boss (Single Resource)

- 1. Describe the proper check-in procedures, and how to lead a crew to complete a specific given task while on an incident.
- 2. Given a description of a tactical assignment, the student will be able to develop a strategy considering consequences and contingencies.
- 3. Describe the proper demo procedures.

# F. FS 87 - Expanded Dispatch Recorder (D-110)

Upon successful completion of this course, the student will be able to:

- 1. Describe the purpose and structure of expanded dispatch
- 2. Describe the role and responsibility of the expanded dispatch recorder
- 3. Demonstrate how to mobilize and demobilize incident resources using established dispatch ordering channels forms
- 4. Describe how to communicate effectively and foster positive interpersonal working relationships.
