# D. FS 93 Fire Fighter I (Table Mesloh/Matta: MSCU)

# **Catalog Description**

This course provides the skills and knowledge needed for the entry level fire fighter, career or volunteer, to perform his/her duties safely, effectively, and competently. The curriculum is based on the 2013 edition of NFPA 1001 Standard for Fire Fighter Professional Qualifications, the 2012 edition of NFPA 1051 Standard for Wildland Fire Fighter Professional Qualifications, and the 2008 edition of NFPA 472 Standard for Competence of Responders to Hazardous Materials/Weapons of Mass Destruction Incidents. The seven overarching themes of the California State Fire Fighter I curriculum are: general knowledge germane to the profession, fire department communications, foregrounds operations, rescue operations, preparedness and maintenance, wildland suppression activities, and hazardous materials/WMD. Student will receive a California State Fire Marshall Fire Fighter 1 certificate. Effective: Spring 2017 Pending Chancellor's Office Approval

## A. MATH 157A Fractions Basic Skill

Discuss new basic skills course. Non-credit/2 hours lecture/18 hours lab Catalog Description

This course covers mathematical basic skills and problem solving for students needing a refresher in fractions. Through an online assessment, this open entry course using ALEKS.com focuses on the basic skills students need in fractions prior to or when concurrently enrolled in another math course. Instruction is individualized through ALEKS.com. This is a non-credit course.

We cannot earn apportionment for online non-credit courses. Since we already have ALEXS way can't we direct the student to use it in math lab? Since the program directs the students it would seem we are paying an instructor not to teach. We need something more concrete as to why we should offer these classes to bring this back for discussion.
