A. <u>Definition of Hybrid delivery and Web-enhanced Course (Achenbach/Baker Table)</u>

Approve change in definitions or that they should remain the same.

Hybrid Delivery

A course in which, any portion of the traditional face-to-face delivery of instruction is replaced by online delivery of instruction, including assessment. (Requires separate Curriculum/Academic Standards Committee approval prior to offering the course)

Web-Enhanced Course

Course in which 0% of the face-to-face instruction is replaced by online instruction; syllabus, chat, email and other supporting materials may be delivered online; online research may be required. (Does not requires separate Curriculum/Academic Standards Committee approval prior to offering the course.)

Effective: Fall 2018

DRAFT definition: Hybrid Delivery

A **hybrid course** is a course in which some partion of the hours scheduled for the traditional face-to-face delivery of instruction is replaced by online delivery. Exams and summative assessments must be administered during scheduled face-to-face hours. (Hybrid delivery requires separate Curriculum/Academic Standards Committee approval prior to efforing the course)

- The catalog description must be revised to include the following statement: This course has been approved for hybrid delivery. Student must have regular access to a computer with Internet (or Access to a computer with Internet access is required).
- Methods of Dellvery on the COR must be revised to include clear guidelines for the number and type (lecture or (loc)) of hours being taught face-to-face, the number of hours being taught online, the types of instruction that may occur in the face-to-face portion of class, and the types of instruction (loct may occur in the online portion of class.
- Methods of final uation on the COR must be revised to include the types of evaluation that will or may occur face-to-face and the types of evaluation that will or may occur online.

DRAT definition: Web-Enhanced Delivery

A **web-enhanced course** is a course in which additional information and resources may be made available to students online, and students may be required to do research and complete and/or submit assignments online. Quizzes may be administered online, but exams and summative assessments must be administered face-to-face. (Web-Enhanced delivery requires separate Curriculum/Academic Standards Committee approval prior to offering the course).

- The catalog description must be revised to include the following statement: This is a web-enhanced course. Students must have regular access to a computer with Internet (or Access to a computer with Internet access is required).
- Methods of Delivery ... doesn't seem that it needs revision for web-enhanced, does it?
- Methods of Evaluation on the COR must be revised to include the types of evaluation that will or may occur face-to-face and the types of evaluation that will or may occur online.

Approved adding hybrid delivery.

Hybrid Delivery Evaluation

All quizzes and exams will be administered during the in person class time. Students will be expected to complete on line assignments and activities equivalent to in class assignments and activities for the online portion of the course. Electronic communication, both synchronous and asynchronous will be evaluated for participation and to maintain effective communication between instructor and students.

Hybrid Delivery

A combination of traditional classroom and online instruction will be utilized. Each semester 17 lecture hours and all 51 lab hours will be taught face-to face by the instructor and 34 lecture hours will be instructed online through the technology platform adopted by the District. Traditional class instruction will consist of lectures, visual aids, and group presentations. Online delivery will consist of participation in forum-based discussions and posts, web links, email communications, lecture posts, and online lectures.

C. BUS 75, 76, 77, 78, & 79 MATH 60 & 103 (Aschenbach/Lewis: MSCU)

Approved removing hybrid delivery for incarcerated student's language from the course out. In the last meeting correspondence is not considered distance education therefor it cannot be considered hybrid delivery.

D. CA 31 Computer Applications I (Mesloh/Haynes Tabled: MSCU)

Approve course for hybrid delivery.

Hybrid Evaluation:

A combination of traditional classroom and online evaluations will be used. Traditional Classroom: exercises/assignments, objective examinations and essay examinations. Online delivery: exercises/assignments, online quizzes and exams, essay forum postings, and chat rooms.

Hybrid Delivery:

A combination of traditional classroom and online instruction will be utilized. Each semester a minimum of 17 hours will be taught face-to-face by the instructor and the remaining hours will be instructed online through the technology platform adopted by the District. Traditional class instruction will consist of exercises/assignments, lectures, visual aids, and practice exercises. Online delivery will consist of exercises/assignments, lecture posts, discussions, adding extra resources and other media sources as appropriate.

Effective: Fall 2018

The course is 68 hours 17 minimum is less than a third of the class. Would like it to be specific how many hours are taught face-to-face and sow many will be taught online. Would like tests and exams to be in the face-to-face instruction.

E. CD 27 Children with Special Needs (Mesloh/Lewis: MSCU)

F. FS 61 Basic Firefighter Training (Basic 32) (Aschenbach/Mesloh: MSCU)

Approved change in catalog description. Remove S-133 & S134.

This course provides basic training in wildland fire suppression and crew person subject overage includes wildland fire behavior, skills of wildland fire suppression, practice with common fireline hand tools, and working safely in wildland fire environment. [Meets U.S. Forest Service and Bureau of Land Management requirements for Firefighter Type 2: S-110, I-100, L-180, S-130, S-133, S-134, and S-190.] Certificates will be awarded at the completion of course.

G. FS 98.20 Annual Hired Equipment Refresher (Aschenbach/Mesloh: MSCU)

Approved change in catalog description and increase lecture hours from 8 to 8.5. This course provides an annual review and update of regulations and guidelines for the safe operation of fire suppression equipment. This course requires an additional fee of \$2.00 to cover the costs of handouts and a pocket guide. Also required is a \$20.00 fee for State Fire Training Certification/Registration fee as mandated by Cal Fire. There is also a \$2.00 fee for a certificate. This course may be taken as legally mandated.

H. GSS 52BR Firearms Training Refresher (Aschenbach/Mesloh: MSCU)

Approved adding .5 hours to lecture. Requires 8.5 hours for .5 unit lecture.
