

Special Admit Students Grades 9-12 Steps to Enroll in College while attending High School

- Complete the online Application for Admissions- OpenCCC (Instructions are on the reverse side →)
- 2. **Login in to MyLassen (the LCC Student Portal).** If you have any issues, please contact the Help Desk at 530-251-8844.
- 3. **Go to the website, <u>www.lassencollege.edu.</u>** Click on "NEW STUDENTS" under the picture. To the right of the screen, click on "ONLINE ORIENTATION" box. Enter your Lassen email address, and password, and complete the Orientation.
- 4. Meet with your High School Counselor to select college classes. Classes must be written on the Special Admit Form, with Section Numbers Ex: (C4854) and Course Titles Ex: (Psy 1). The principal or designee from your school must sign the form authorizing you to enroll in college courses. (Special Admit registration form is attached) *
- 5. <u>Your Parent or Legal Guardian must sign the Special Admit Form</u>, giving permission for you as a High School Student to attend classes at Lassen Community College.
- 6. You are now ready to meet with a Counselor at Lassen Community College. You must bring your high school transcript and Special Admit Form for the Counselor to approve. (Students enrolling in more than 6 units must obtain the Dean's signature after meeting with the college counselor.)
- 7. When the above steps are complete, <u>bring your signed Special Admit Form to</u> the Admissions & Records Office to register for your classes.
- 8. **Tuition is Free! There are No More Student Fees!** You are only responsible for Materials Fees (Example Art 36A = \$10 Materials Fee) and, of course, your books.

How to Complete the Online Application for Lassen Community College

- 1. Go to www.lassencollege.edu after you open the internet browser.
- 2. Click on <u>APPLY NOW</u> to begin the 2-step application process. (First, create a user account, then sign-in, **then** sign-in to complete and submit the 9-part application.)
- 3. Click on **CREATE AN ACCOUNT**.
- 4. Click on **BEGIN CREATING AN ACCOUNT** and fill in the boxes with your information.
- 5. You **MUST** enter your physical address, where it asks for Permanent Address.
- 6. Page 3 of 3, Create a Username and Password that you can easily remember.
- 7. Once you create your account, you will click the <u>Continue Button</u> and be taken to the Sign-In page. Sign-In with your newly created Username and Password.
- 8. Once you've signed in you will lick on **Start a New Application.**
- 9. Under the **Account/Mailing Information** tab, you will see your information and at the bottom, **Current Mailing Address**. This is where you can add your mailing address, if it is different from your physical address.
- 10. If you attended a charter school (ex. Westwood Charter), you will click the <u>I Attended High School</u> option. The second and third option is for students that were taught at home by their parents.
- 11. At the end of the application, you will click on the **Submit My Application** button
- 12. **Congratulations!** You have successfully completed and submitted your application to Lassen Community College! The next screen is confirmation that you submitted your application; keep a copy for your records.
