### Action

1. To approve revised IPR Annual Update Template (Swanson/Gardiner MSCU) Discussion addressed redundancy that was identified between item 5 and 8 in the draft document. It was recommended that item 11 be deleted. Language was updated to blend items 5 and 8. The revised item 5 will read as,

"Outcome Assessment (SLOs/PSLOs/AUOs): Specify any emerging needs based on assessment of outcomes (SLO, PSLO or AUO). Specify any planning or budget changes (ie. human, facilities, equipment, technology, financial, professional development) based on assessment of outcomes assessment. Include any examples of changes that resulted in improved SLO, PSLO and/or AUO findings."

2. To approve Basic Skills IPR and forward to the Board (Gardiner/Beterbide MSCU) Discussion included that the final revision included additional information regarding class sizes.

#### Senators

Lisa Gardiner, Minimum Qualification and Equivalency Chair, shared three minor revisions in the finalized MQ Handbook under *The Verification Process* which addressed; 1) the forwarding of approved equivalencies from the President' Office to Human resources, 2) documentation suggestions for self-employed applicants to support, "conclusive evidence of full time work experience", and 3) moving the equivalency appeal procedure from the back of the handbook to page 8 where equivalency is addressed.

President Aschenbach brought to Senate's attention that Senators teaching schedules allow for an earlier meeting time this semester. It was resolved Senate meetings will begin at 3pm on current days scheduled.

Dr. Vasquez identified her need to be involved in the Minimum Qualification/Equivalency approval process and requested that Senate visit this in future MQ Handbook revisions. President Aschenbach added that the same consideration is being review in regards to Curriculum Committee functions.
