- Adam Runyan had requested that the IELTS (International English Language Testing System) be considered to be used in addition to the TOFEL (Test of English as a Foreign Language) when certifying English proficiency. Per President Aschenbach, the AP already allows use of both IELTS and TOFEL tests/scores.
- Per Baston, John Martin had requested clarification on why the NRA/POST program reviews were included in the Gunsmithing 2 year cycle reviews? Per discussion, Senate agreed that this was a good question and that more exploration
