Approve revisions to clarify Minimum Qualifications for the discipline Emergency Medical Technologies: Discussion included input from Chad Lawson in regards to additional language for the MQ's for EMT. This language will now include "Instructor 1 Methodology" in addition to State Fire Marshal Instructor 1A and 1B as acceptable completion of instruction in teaching methods. - 2. Approve recommendations from Curriculum/Academic Standards Committee and forward to the Board: *Approval of Fire Technology classes FS 54, 91 with substantial changes to FS 57* (Gardiner, Nyman/MSCU)

Approve BP and AP 3715 Intellectual Property Rights: With discussion and input from faculty members regarding "Substantial Use of District Resources", clarification has been added to include any "load and overloads" to the definition.
