1. AP 5075 Course Adds and Drops

A number of questions were raised in regards to when the last day to add a course should be. Do we have success rates for students enrolling before first day of a class and those enrolling after? Could CG1 be a standard late start class for students arriving after the first day of classes? Additional concerns: allowing adds in 2nd week is extra work for faculty, reduces the importance of instruction in the 1st week; enrolling late puts students at an immediate disadvantage. This will be discussed further in the future.
