1. Elections

2. Guided Pathways

President Aschenbach provided an update on the IEPI Guided Pathways workshop that was held in Sacramento on February 26. The group will meet in March to work on the work plan that is due at the end of March. It will likely have some high-level planning-related items, including some from Integrated Planning, as LCC is still in the evaluation and planning stage of guided pathways. The work plan will come to senate for two readings in March.

- 3. New Board Policy Regular, Substantive Contact in DE
 President Aschenbach shared that although Senate has used the Online
 Instructor Handbook to clearly define our expectations for regular, substantive
 contact in distance education sections, most colleges have a policy which helps to
 further formalize local definitions and expectations. A DE policy can also help to
 meet accreditation standards. Cheryl has done research to see what other
 colleges have in their DE policy and will present a draft at the next meeting.
