3. AB705

Aschenbach gave update on State requirements and Fall 2019 deadline.

4. AP 4255 Disqualification and Dismissal

One student that previously attended and had W's and F's. Gone for a few years. Clearly more focused and has done very well. Aschenbach will give feedback that the Dean of Student Services has a right to appeal dismissals when the student has successfully completed a semester despite being below a 2.0.

5. BP 5010 and AP 5011 re: assessment of special admit students BP 5010

Runyan asked why we have a classification for special full-time student, when our current policy is up to 11.5 which is only part time. There has been at least one exception to this policy, so special full-time language may need to be kept. Cheryl will check on Education Code.

AP5011

Runyan recommended that under "Admission is subject to seat availability. The student must submit:" Point three – remove "his/her principal" and replace with school designee. Same under The student must submit on page 3.

Runyan gave an update of other institutions policies and recommended that the senate wait until the counseling staff can recommend a new process for this population.

6. AP 5012 International Students

Runyan recommended to the senate that under General Admission Standards for International Students an exception be added that states: "The TOEFL or IELTS will be waived if a student has studied in a school for two academic years with at least a 2.0 GPA where the medium of instruction is English and the school holds regional accreditation." Runyan recommended that under Insurance Coverage for International Students, the second sentence be taken out "This insurance will be made available during registration." International Students are expected to show proof of insurance before receiving the I20 Invitation.

7. Incarcerated Handbook

Continued discussion to increase support and better prepare/train new faculty. Plan a meeting to discuss.

Rupley recommended an NIPR be completed for Incarcerated Program
