The Academic Senate was challenged by the fact that four fall evaluations are still not complete because packets are missing documents or signatures, and therefore those packets could not be provided to the senate for review. Senate took three actions related to faculty evaluations and contract recommendations:

- 1. The senate took action to have President Aschenbach compose a letter to Dr. Hall explaining senate concerns about timing of meetings, including that multiple faculty evaluation meetings and classroom observation visits were cancelled and individual employee evaluation paperwork was not provided to faculty at the end of the process. The letter should also include the recommendation that administrators and participating faculty be trained on effective evaluation practices as well as the specifics of the LCC full-time faculty evaluation process. - 2. The senate took action to accept the contract recommendations and forward them to Dr. Hall and the Board for those packets which are complete and were given to senate for review (Runyan/Haynes) MSCU
- 3. The senate agreed to take no action regarding evaluations and contract recommendations for the four faculty for whom no packets were received because they are yet to be completed.
