Definition of Hybrid Course and Web-enhanced Course

Approved changes in definitions.

A **hybrid course** is a course in which some portion of the hours scheduled for the traditional face-to-face delivery of instruction is replaced by online delivery. Exams and summative assessments must be administered during scheduled face-to-face hours. (Hybrid delivery requires separate Curriculum/Academic Standards Committee approval prior to offering the course)

- The catalog description must be revised to include the following statement: This course has been approved for hybrid delivery. Access to a computer with Internet access is required.
- Methods of Delivery on the COR must be revised to include clear guidelines for the number and type (lecture or lab) of hours being taught face-to-face, the number of hours being taught online, the types of instruction that may occur in the face-to-face portion of class, and the types of instruction that may occur in the online portion of class.
- Methods of Evaluation on the COR must be revised to include the types of evaluation that will or may occur face-to-face and the types of evaluation that will or may occur online.
 - A **web-enhanced course** is a course in which additional information and resources may be made available to students online, and students may be required to do research and complete and/or submit assignments online. Quizzes may be administered online, but exams and summative assessments must be administered face-to-face. (Web-Enhanced delivery requires separate Curriculum/Academic Standards Committee approval prior to offering the course).
- The catalog description must be revised to include the following statement: This is a web-enhanced course. Access to a computer with Internet access is required.
- Methods of Delivery ... doesn't seem that it needs revision for web-enhanced, does it?
 Methods of Evaluation on the COR must be revised to include the types of evaluation that will or may occur face-to-face and the types of evaluation that will or may occur online.
