#### **Progress Report**

The business Department wants to make a request for the main business classroom to be upgraded. Since there will be no face-to-face classes in the 2020-2021 academic year, we are not in need of our classroom. This means the classroom can be updated based on the 2016-2020 Business IPR recommendation. In addition, there has been a significant change to the main degree offered in our program, the AD-T in Business Management, which means we will need to wind down some of the locations served and will no longer need as much support as recommended in the 2016-2020 Business IPR.

#### Curriculum

There are no updates to curriculum at this point. Updates are being made based on changes to C-ID and will come later in this year. The courses recommended for change are BUS 1A: Financial Accounting, BUS 1B: Managerial Accounting, and the AD-T in Business Management in the areas of electives and core.

#### **Program Needs Assessment**

The business Department is in need of new physical space for face-to-face courses. The current classroom does not meet code and is in need of remodeling as it is an old television studio. This means the business Department is requesting a new updated classroom to include desks, computers, chairs, instruction podium, projector, white boards, and student friendly material for a flipped classroom to maintain student learning outcomes, such as multiple small white boards on walls to aid in pod learning.

#### **Progress and Reprioritization of Recommendations**

There are a few changes that will need to be made on the prioritization of human resources due to a change in the business degree for transfer. They are as follows:

- 1. Remodel room CA-123A to meet code and provide a better learning environment
- 2. We will no longer need a temporary full-time instructor
- 3. There is no need for additional ISS positions
