# AJ-60 Adult Correctional Officer Core Course

9.5 Units

### I. Catalog Description

This course presents and meets the required training for entry level local correctional officers by the Board of State and Community Corrections, Standards and Training for Corrections (STC). Topics include: criminal justice System, professionalism and ethics, gangs, oral and written communication, maintaining security, booking, receiving and releasing offenders, supervising offenders, medical issues, classification of offenders, cultural awareness, report writing and record keeping, emergency procedures, visitation, screening and distribution of supplies and mail, transportation, testifying in court, assault and abuse, defensive tactics and restraint techniques, behavioral health and personal This course is designed to provide practical hands on physical conditioning basics. training in correctional officer tactics and weapon usage, participants in this course will engage in physically demanding classroom training exercises that include a potential risk of injury to the participants. Students need to be prepared for the rigor of the physical conditioning and defensive tactics training. Pre-existing medical conditions may interfere with successful completion of these sections and/or the course. Course instructor signature required for enrollment. Material fees of \$50.00 per student collected at time of registration.

Prerequisites: Must be 18 years of age and have High School Diploma or GED.

**Recommended Preparation**: Successful completion of ENGL105 or equivalent multiple measures placement.

## A. Course Student Learning Outcomes

Upon completion of this course the student will be able to:

- 1. Identify and demonstrate the major tasks and responsibilities of an adult correctional officer in a detention facility.
- 2. Identify and describe the overall mission of the adult correctional officer and its place in the California criminal justice system.

## **B.** Course Objectives

Upon completion of this course the student will be able to:

- 1. Describe the fundamental roles, responsibilities, duties, obligations, influences, and philosophy inherent with being a correctional officer.
- 2. Describe the significance of the Minimum Standards for Local Detention Facilities as defined in the California Code of Regulations, Title 15.
- 3. Identify key legal requirements related to confidentiality and release of information.
- 4. Identify why officers should exemplify the highest ethical and moral standards while on-duty and off-duty.
- 5. Identify officer safety issues related to gang behavior in and out of custody setting.
- 6. Communicate effectively and professionally using written, oral, and electronic methods.
- 7. Recognize and describe the indicators showing the need for medical or mental health attention.
- 8. Identify the proper procedure for the use of keys, sally ports, doors, gates, safety cells, and general housing areas.
- 9. Describe the purpose and procedure for conducting numerical counts.
- 10. Identify the considerations for conducting facility searches.
- 11. Describe the requirements regarding the medical screening of incoming offenders, according to California Code of Regulations, Title 15.
- 12. Identify the different types of releases.
- 13. In a given scenario, effectively use proper communication to de-escalate a potentially violent situation.
- 14. Explain the correct procedures for booking an individual into custody, to include religious rights, personal property and phone calls.
- 15. Identify the justifications for use of force on an inmate.
- 16. Illustrate the importance of classification and segregation of inmates, including at risk factors, gangs, and health concerns.
- 17. Identify the skills necessary to handle emergencies, fires, life safety issues and evacuations.
- 18. Presented with a scenario, generate a proficient written report of the incident.
- 19. Identify the California Code of Regulations, Title 15 mandates and postal regulations relevant to the opening and reading of legal and non-legal mail.
- 20. Define zero tolerance as it applies to sexual assault, abuse and harassment.
- 21. Identify psychological and physiological factors that may affect an officer who is threatened or involved in a physical altercation with an offender.
- 22. Identify potential health hazards faced by an officer when confronted by or using force against an offender.
- 23. In a simulation, demonstrate at least two course instructed control holds incorporating the following: balance, maintaining a position of control and advantage, proper foot movements and leverage/assistance.
- 24. Determine the best means to identify the emotional/mental state of an offender.
- 25. Explain key components of a performance-based fitness program and the ways each contributes to fitness.
- 26. Explain the purpose and goals of performance-based conditioning for adult corrections officers.
- 27. Show proficiency in physical fitness as outlined in the California Adult Correctional Core Manual.
