#### **Consultation Council**

- 1. Personnel Update (Information) Vickie Ramsey Outreach Coordinator position ready to fly this week. Auxiliary Manager going to fly this week. Programmer is flying this week. We have good candidates for the Director of Institutional Effectiveness position and are still receiving applications for the VP and Dean positions. These last positions close March 1. We are currently \$200,000-\$300,000 underfunded for the positions being flown, so we may need to put some on hold.
- 2. Budget Update (Information) Terry Bartley Dave is finishing TRAN paperwork and we should be funded next week. We are uncertain about a deficit coefficient being talked about by the Chancellor's Office. Could by 6-8% but we won't know until April or so.

#### Strategic Planning

1. Updated Outreach Coordinator Job Description (Information) – Dave Clausen

The salary and grade range were updated, and the rest of the job description essentially stayed the same. There is still some question why Outreach Coordinator is grade 18 and Director of Athletic Operations is grade 16; this is a difference of about \$3,000. A question was asked about the duty, "Build a webpage." This is not a technical skill, it is a matter of providing and maintaining content for a web page. The position will be funded through international and out-of-state fees, but it is unclear if there will be addition budget necessary for travel. Patrick replied that there was a budget in the past, but it was utilized elsewhere last year. Some of the past budget is being restored, but the amount is unclear. We will see the planned budget as part of the budget process in March.
